WHEREAS, the entity is desirous that the Contractor execute the **CONCRETING OF FARM-TO-MARKET ROAD AT BARANGAY MATUGNAW, TANGUB CITY** (hereinafter called "the Works") and the Entity has accepted the Bid for **SIX MILLION SIX HUNDRED FIVE THOUSAND TWO HUNDRED THIRTY-ONE PESOS & 38/100 ONLY (Php6,605,231.38)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

If the Contractor fails to satisfactorily execute and complete the works within the specified maturity schedule, the CONTRACTOR shall be liable for damages for the delay, and shall pay the ENTITY, LGU-Tangub City liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of the one percent (1%) of the cost of the delayed until such contracts are finally completed and accepted by the ENTITY.

6. In no case shall the total sum of liquidated damages exceed fifteen percent (15%) of the total contract price, in which event the ENTITY shall automatically terminate the contract and impose appropriate sanctions over and above the liquidated damages to be paid.
7. The ENTITY hereby covenants to pay the CONTRACTOR in consideration of the executions and completion of the works and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
