CITY ORDINANCE NO. 2025-02-011

AN ORDINANCE AMENDING SECTION 4 OF CITY ORDINANCE NO. 2022-11-054, OTHERWISE KNOWN “AS AN ORDINANCE PRESCRIBING THE TARIFF FARE PER PASSENGER TO ALL PEDICABS AND TRICYCLES FOR HIRE OPERATING IN TANGUB CITY”

Sponsored by: Hon. Romulo L. Del Socorro

WHEREAS, Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, grants every local government unit (LGU) the power to exercise its authority necessary for the promotion of general welfare, including regulating public transportation within its jurisdiction;

WHEREAS, Section 458(a)(3)(vi) of the Local Government Code empowers the Sangguniang Panlungsod to regulate the operation of tricycles and prescribe their fare rates in accordance with existing laws, rules, and regulations;

WHEREAS, the Department of the Interior and Local Government (DILG) and the Department of Transportation (DOTr) have issued joint memorandum circulars providing guidelines on fare adjustments for public utility vehicles, including tricycles and pedicabs, to ensure reasonable and fair fares for both operators and commuters;

WHEREAS, the current fare rates prescribed under City Ordinance No. 2022-11-054 need to be updated to reflect the rising costs of fuel, maintenance, and other operational expenses, which directly impact the livelihood of pedicab and tricycle operators in Tangub City; and

WHEREAS, under the proposed fare structure, a base fare of Fifteen Pesos (₱15.00) shall be applied to all trips, with an additional charge of Five Pesos (₱5.00) per kilometer beyond the base distance;

WHEREAS, trips originating from the Integrated Bus and Jeepney Terminal (IBJT) and passing through the city proper shall incur an additional charge of Ten Pesos (₱10.00) to account for increased operational costs and traffic conditions;

WHEREAS, the adjustment of fare rates aims to establish a fair and balanced system that considers both the welfare of passengers and the sustainability of earnings for tricycle operators;

BE IT ORDAINED BY THE MEMBERS OF THE SANGGUNIANG PANLUNGSOD OF TANGUB CITY IN SESSION ASSEMBLED, THAT:

SECTION 1. Section 4 of City Ordinance No. 2022-11-054, which prescribes the tariff fare per passenger for all pedicabs and tricycles for hire operating in Tangub City, is hereby amended to state as follows:

SECTION 4. UPDATED FARE RATES. The City of Tangub hereby prescribes the updated fare rates for all pedicabs and tricycles for hire operating within the jurisdiction of Tangub City, Misamis Occidental, as follows:
