Supply of Goods for the project/contract: PURCHASE OF VARIOUS COMPUTER SET AND EQUIPMENT FOR GADTC COLLEGE INFORMATION SYSTEM (CISO) AND COLLEGE MULTI-MEDIA OFFICE.

This AGREEMENT made this 15<sup>th</sup> day of JUNE 2023 between the Local Government Unit of Tangub City (hereinafter called the "Entity") of the one part and **RITCHE-NATHALIE BUILDERS AND GENERAL MERCHANDISE** (hereinafter called the "Supplier") of the other part:

WHEREAS, the Entity invited bids for the purchase of various supplies and has accepted a bid by the Supplier for the supply of those goods and services in the sum of **ONE MILLION THREE HUNDRED THIRTY EIGHT THOUSAND TWO HUNDRED PESOS ONLY (Php 1,338,200.00)** called the "Contract Price".

Now this AGREEMENT WITNESSETH as follows:

- In this Agreement, words and expressions shall have the same meaning as are respectively assigned to them in the conditions of the contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz:
  - a. the Bid Form and the Price Schedule submitted by the Bidder;
  - b. the Schedule of Requirements;
  - c. the Technical Specifications;
  - d. the Entity's Notification of Award;
  - e. the Notice to Proceed Delivery Schedule; and
  - f. the Quantities specified in the Purchase Orders.
- 3. In consideration of the payment to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier covenants with the Entity to provide/deliver the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract Agreement.
- 4. If the supplier fails to satisfactorily deliver the goods within the specified delivery schedule, the SUPPLIER shall be liable for damages for the delay, and shall pay the ENTITY, LGU-Tangub City liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of the one percent (1%) of the cost of the delayed goods scheduled for delivery for everyday of delay until such goods are finally delivered and accepted by the ENTITY.
- 5. The ENTITY need not prove that it has incurred actual damages to be entitled to liquidated damages. Such amount shall be deducted from any money due or which may become due to the SUPPLIER or collected from Bid Security posted by the SUPPLIER, whichever is convenient to the PURCHASER.

- 6. In no case shall the total sum of liquidated damages exceed fifteen percent (15%) of the total contract price, in which event the ENTITY shall automatically terminate the contract and impose appropriate sanctions over and above the liquidated damages to be paid.
- 7. The ENTITY hereby covenants to pay the SUPPLIER in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract.
